1	The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika 1, 2 and 3 respectively). The total number of sections from classes I to XII shall be restricted to 17, of which not more than 1/3rd sections may be used for senior secondary classes. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by e law and availability of class rooms of greater than 500 sq. ft. dimension. The number of students in each class shall be restricted to 40.

Only 1 CwSN toilet for girls' along with general toilets is seen on the ground floor of main building block. Boys' toilets are not seen in the main building. It has been observed that school has made provision of separate toilet block having general and CwSN toilets for boys & girls, which is outside the main academic building. The School shall make provision of separate toilets for CwSN for boys and girls on every floor, with proper permanent signage, indicating the floor number and all infrastructural facilities, as per norms of RPwD Act and guidelines of the Board within 3 months and submit the compliance.
3	The school shall ensure the training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
